

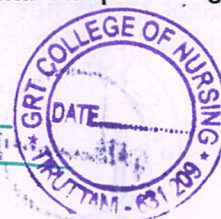

In the reference 3<sup>rd</sup> cited, the Government in G.O(Ms).No. 97, Health and Family Welfare (PME) Department, dated 30.04.2013 has granted permission to change the name and style of the Institution mentioned in the Government Order first read above (viz), **BKR College of Nursing, Tiruttani**, Thiruvallur District to "**GRT College of Nursing**" Tiruttani, Thiruvallur District and the name of the administration of the Trust from "**Sola Dhaniskodi Raja Thai Ammal Memorial Educational Charitable Trust**" to "**G.R.T Mahalakshmi Educational Charitable Trust**".


